**Agenda approval**: Bronstad motioned to approve  $-2^{nd}$  by Linton. carried.

**Consent agenda:** Linton motioned to approve: March council minutes, March city claims, Chuck Harrison resignation from Airport Committee effective April 1,  $2014 - 2^{nd}$  by Waite. Carried.

**Reports:** Bronstad motioned to approve March Community center minutes, February Housing Authority minutes, March Library minutes. 2<sup>nd</sup> by Linton. carried.

**Old business/updates:** <u>Ordinance 737A</u> – revising terms for Direct Sellers from annual license to weekly, monthly or 3-month permit – Linton motioned to approve. 2<sup>nd</sup> by Morley – carried. <u>Ordinance 738A</u> – Farmers Market ordinance revisions – motion to approve by Linton, 2<sup>nd</sup> by Bronstad. Carried.

Linton motioned to release department survey's to the Chetek Alert. 2<sup>nd</sup> by Waite. Carried.
