Carried. **Bronstad motioned to approve the hiring of Aaron Robert** in the public works department effective  $9/29/14 - 2^{nd}$  by Morley. Carried. Bronstad motioned to approve **Resolutions 2014-14 and 2014-15** appropriating money to police office account and police equipment account respectively.  $2^{nd}$  by Waite. Carried. **Edwards motioned to approve revised fee schedule** increasing the public works charges for garbage service, equipment and labor charges- $2^{nd}$  by Morley. Carried.
